On 18 August, the Working Committee of the Tamilnadu Peoples' Forum for Social Development, following the External Evaluation and Strategic Planning, decides to turn the Forum secretariat at Chennai into a Public Policy Advocacy Research-cum-Resource Centre. Fr. Manu, one of the Conveners of the Forum, volunteered to develop the Centre. The new Centre was named Social Watch – Tamilnadu (SW-TN).

On 18 September, New Entities for Social Action (NESA), Bangalore, requested Fr. Manu to undertake a Review of its Dalit Sector Support Team (DSST) work in Tamilnadu and Karnataka.

During 22-24 September, Fr. Manu presented a paper on "Women Component Plan – A Holistic Gender Budgeting Tool" at the International Gender Budget Workshop, organized by the Women Study Centre, Utkal University, Bhubaneshwar, Orissa.

During 27 October – 1 November, Fr. Manu presented his Review Report of NESA's DSST work, at NESA's Strategic Management Workshop.

On 24 November, Fr. Manu represented SW-TN at the national consultation on "Understanding Budget Work in India", organized by Ford Foundation and the Centre for Budget Accountability (CBA) at New Delhi and was a panelist on "Current State of Budget Work in India".

On 24 November, Fr. Manu represented SW-TN at the CBA core committee meeting at New Delhi.

On 6 December, SW-TN, in collaboration with the Human Rights Forum for Dalit Liberation (HRFDL-TN), organized a Seminar at Chennai on 'Empowerment of Dalits in Actualising Opportunities and Government Interventions'. The seminar, addressed by many bureaucrats and legislators, attracted more than 250 participants, including dalit activists and researchers.

During 16-18 January, Fr. Manu and two staff members represented SW-TN at the World Social Forum at Mumbai and collaborated with the NCDHR and the National Social Watch Coalition in organizing workshops.

On 23 February, Fr. Manu represented SW-TN at the Consultation organised by Ford Foundation at New Delhi.

On 6 & 13 March, SW-TN, along with Dalit Panchayat Presidents Forum (DPPF) and Legal Resources for Social Action (LRSA), organised 2 day-long Consultations, at the SW-TN office and at Chengalpet respectively, for 10 Dalit Panchayat presidents to acquaint them with strategies for self empowerment.

On 8 March, Fr. Manu gave the keynote address on "Human Rights and Social Work" to the M.SW. students of St. Aloysius College, Mangalore at their National Workshop.

On 12 March, Fr. Manu addressed the TNVRC session on Budget Advocacy.

On 27 March, SW-TN, along with DPPF and Rural Development Society (RDS), organised at Chennai a day-long consultation for about 30 dalit panchayat presidents.

On 2 June, Fr. Manu represented SW-TN at the Core Group Meeting to plan for the registration of CBGA at New Delhi.

During 7-10 June, Fr. Manu participated at the FABC Conference, held at Seoul, South Korea, in his capacity as the Asia-Pacific Adviser of ICMICA.

During 11-13 June, Fr. Manu represented SW-TN at the National Convention on Right to Food and Work, at Bhopal, organised by the National Campaign on Right to Food.

On 21 June, Ms. Kamatchi joined SW-TN as Research Assistant.

On 23 June, SW-TN organised a consultation to discuss about lobbying points for dalits during the 2004 State Budget session.

During 25-26 June, Fr. Manu was the facilitator at the dialogue session among CRY, TAFRE and CACL, at Crenieo Centre, near Chennai.

In July, SW-TN released the revised version of its monograph, "Special Component Plan – Dalit Hopes Betrayed?" (both in English and Tamil).

During 4-8 July, Fr. Manu, on the invitation of the Chennai Office of Action Aid International, was a member at the Field Review of Dalit Mannurimai Koottamaippu (Dalit Land Rights Federation) and presented the final Report, "DMK - Review Towards a Perspective Plan".

On 22 July, SW-TN organised a get-together of the members of the Tamilnadu Dalit Legislators Forum, along with a few bureaucrats and dalit activists, in view of the forthcoming Budget Session of the State Assembly.

During 23-30 July, Fr. Manu, in his capacity as Asia-Pacific Advisor, participated at the International Assembly of ICMICA, held in Poland.

In August, SW-TN initiated efforts towards setting up a 'Dalit Budget Desk' at New Delhi, as a collaborative venture by CBGA, NCDHR and SW-TN.

The August issue of CBGA's Budget Track carried an article by Fr. Manu, "Dalit Budgeting in Tamilnadu – Experiences in Budget Advocacy".

On 3 August, Action Aid Chennai Office invited Fr. Manu to be part of the group to evolve a Status Report of Children in Tamilnadu.

On 7 August, Fr. Kumar was a resource person on Dalit Budgeting at the Dalit Panchayat Presidents State Executive Committee Meeting at Trichy, Tamilnadu.

On 13 August, Fr. Manu represented SW-TN at the one-day Consultation on "MPLADS: Relevance, Efficacy and Contradictions", organized by CBGA at New Delhi.

On 16 August, SW-TN, in collaboration with the Department of Sociology, University of Madras, organized a National Seminar on "Special Component Plan – A development Strategy in empowering Dalit masses". The Seminar, co-sponsored by NCDHR and HRFDL-TN, attracted about 120 participants, including civil servants, students and activists. A memorandum was submitted to the National Commission for Scheduled Castes.

During 8-9 September, Fr. Kumar was the main resource person at the workshop on Dalit Perspective Building, organized by IGSSS and participated by 30 NGO heads from different parts of Tamilnadu.

During 17-19 September, Fr. Kumar was a resource person at the Seminar on 'SCP and Development of dalits in Tamilnadu', organized by ANITRA Trust at Chittoor, Andhra Pradesh.

On 24 September, Fr. Kumar spoke on "Dalits and Food Security", at the 3-day workshop on "Dalits and ESC Rights", organized by Rural Development Society at Chennai. Members of NGO networks from the northern districts of Tamilnadu, involved in dalit mobilization, participated.

During 9-10 October, SW-TN organized, in collaboration with Vaanmuhil, a 2-day State-level Conference, at Tirunelveli, South Tamilnadu, on "Reservations in Private Sector". The participants numbered more than 350, consisting of University students, social activists, lawyers, members of political movements and intellectuals. Leaders of almost all the major Dravidian, dalit and Left parties and movements in the State addressed the Conference.

During 11-12 October, SW-TN organized a two-day consultation on Tribal Budget Analysis at Salem, Tamilnadu.

On 16 October, SW-TN was an active collaborator and participant at the high profile Conference, at Chennai, on "Government of India Budget on SC/ST Socio-Economic Development and Utilisation", organized by Thirukkulam Cinthanaiyalargal Maiyam. The Conference, which was addressed, among others, by Mr. P. Chidambaram, the then Finance Minister, Government of India, attracted more than a thousand participants, including Dalit intellectuals, activists, bureaucrats and legislators.

During 3-4 November, SW-TN, on the invitation of NCDHR and at the National Consultation on MDGs and Dalits at New Delhi, released its publication, "Millennium Development Goals & Dalits – The Missing Dimension".

During 10-13 November, Fr. Manu represented SW-TN at the International Seminar on "Governance, Democracy and Participation", at Loyola, Spain, organized by the International Jesuit Network on Development. Fr. Manu presented a paper at the Consultation, attended by 17 social centres from across the world and was chosen to coordinate the Working Group on Budget Control.

During 22-25 November, Fr. Manu represented SW-TN at the Asian Civil Society Forum in Bangkok.

RittoCyriac, IFS (Director of Tribal Welfare Department, Government of Tamilnadu) held at Dhyana Ashram, Chennai. The tribal representatives were all from the western districts of the state. This was organized in view of preparing a draft budget with recommendations to be circulated among the ministers, the Directors and the Secretaries of the State Government prior to the annual budget for 2018-19.

On 15<sup>th</sup> February 2018, Fr. Kumar along with other Jesuits engaged in Migrant and Tribal Missions, and gave a presentation on *Social Watch's core thrust work – Budget advocacy and policy priority -* with State Government and

Civil Society Forums at a gathering in Chennai Mission Office, when the 'Mission Procurator - Fr.Klaus and Judith from Germany visited Chennai Mission office.

On 21<sup>st</sup> February 2018, Fr. Kumar along with Mr. R.C. Gandhi I.A.S (Retd) presented their tribal research study undertaken at the request of the State Planning Commission of Government of Tamilnadu to enquire into the living conditions *Kadar tribes of Valpaarai, Coimbatore District in Tamilnadu*.
