Intersectional Approach In Fund Allocation Is Needed To Minimise Disparity Based On Caste, Occupation, Geography And Other Vulnerabilities Facing Women

he Tamil Nadu government has been presenting the gender budget statement (GBS) in the Tamil Nadu Legislative Assembly since 2018. For the financial year 2023-2024, the GBS was presented with an unprec-edented increase in the allocation of funds under Part A —schemes with during droughts and floods. 100% outlay benefiting women. One of the notable features was that the alloca-tion of funds is more than twice that in the more than twice that in the previous financial year. The reason for the increased alloca

tion in this financial year could perhaps be for the new Magalir Urimai Thogai scheme, which is set to be launched on September 15 and an increased alloca-



scheme. However, there is a compelling need to adopt a decentralised and intersectional approach in the GBS process due to the disparity in the allocation of resources based on caste, occupation, geography and other vulnerabilities facing women. For instance, the alloca-tion of funds for the 'Safe city projects for women's safety in public places' under the Nirthaya Fund is made only for Chennal and not in other urban or rural areas. But violence against wom-en is not confined only to the state capital. The scope of the budget should address the need for safety of women across the state. An analysis of the GBS also reveals that under Part A there is no specific





- 3. Aadhiyar girls got admitted in Chettinad Dental College in BDS without insistence of any upfront payment.
- 4. Road Formation in 7 places. (Eg. Two km Thar Road Kannagi Mundu Ooty; 6 km Road in Javadhu malai, Thiruvannamalai – got flashed in newspaper as well)
- 5. 62 units of modern flats allotted to Irulars in Kayarampedu
- 6. (First of its kind in country unique scheme for Irulars– 400 sqft, 1+3 flats, gated community with all basic amenities, mosaic flooring
- 7. Eklavya school established in Chengalpattu districts.
- 8. As an outcome of liaison with Thiruvallur Member of Parliament and MLA Mr.Balaji \rightarrow A Irular leader Mr. Gunasekaran has been appointed

as Member of Rural Development Monitoring Committee.

- 9. Crucial needs of Irulars were discussed with MLA Mr. Balaji and the same has been approved by the Govt.
- 10. Constant interaction with Irulars and Tribes, they have gained confidence in administration both locally and at National level.

'Social Watch-TN', PAALAM and 'International Ambedkar Mission (IAM) together organized a "Civil Society Dialogue on Recommendations to be made for the proposed **ACT on 'Development Action Plan for Scheduled Castes** (DAPSC)' formerly known as Scheduled Castes Sub-Plan" on 24th September 2023 at IAS Officer's Mess, SAF Games, Koyambedu, Chennai. The draft kept for deliberation was approved to be sent to the Government. The main features are:

- The Act should not bear the name of SC or ST on it. Therefore "ஓங்குயர் சட்டம்" in Tamil has been proposed. English version can also use the same terminology.
- 2. The objective spells out growth orientation and not just a pacifying share in common schemes.
- 3. In order to usher in innovations year after year, two-way allocation has been recommended.
 - a. One allocation will be on the same formula as existing that will be the proportion based on previous census out of the bundle of welfare schemes.
 - b. The second will be a 3% allocation from the total budget size.
- 4. Allocation made under 3(b) will be utilized only for the new schemes with Saandror (SC) focus only.
- 5. All the funds should be routed through Saandror and Aandror Panchayats only.
- 6. District level disaggregated allocation and utilization should be shown in annual audit.


















