#### 2024 Half-Yearly Diary Social Watch – Tamilnadu

#### **JANUARY**

On 2<sup>nd</sup> January 2024, SWTN organized an Online meeting with key Women Leaders to create a push to the Government to Finalize the State Women Policy Draft 2021. As a follow-up, we filed a RTI demanding the release date of the final policy and to get the revised policy for public opinion. With 92 endorsements from various stakeholders, we have escalated the issue to all 234 MLAs, Minister and Secretary of Department of Social Welfare and Women Empowerment, GoTN. We have restarted the discussion with Chairperson of TN State Women Commission. The same was reflected in Indian Express and DT Next newspaper, dated 7<sup>th</sup> January 2024.

As a success to our joint efforts, on 23<sup>rd</sup> January 2024, Tamil Nadu Cabinet approves Policy for Women; and promised constitution of a State-level committee headed by Chief Secretaries and district-level committees headed by Collectors to monitor the implementation of the policy and to address any issues of discrimination.

On 8<sup>th</sup> January 2024, SWTN in collaboration with Dept of Social Work, Madras Christian College organized the **10<sup>th</sup> Micro Level Plan meet for Chengalpattu Irulars**; at MCC-Tambaram.



On 9th January 2024, Ms. Rajeshwari extended solidarity to the **Training for Solidarity Interpreters** of the 'Nilgiris Particularly Vulnerable Tribal Groups Federation' (NPVTG); Organized by 'South Asian Solidarity Interpreting Collective' at ICSA Paripurna Training Hall, Chennai.





The Gender Budget Statement (GBS) released by the Tamil Nadu government shows a need for an intersectional and decentralised gender budgeting process, according to a fact file on the statement conducted by the Information and Resource Centre for the Deprived Urban Communities (IRCDUC). ... ...

Drawing a parallel to the Punjab government's Gender Budget, which also includes a Part C, S. Kamatchi, assistant director, Social Watch said "The Punjab government's gender budget, which has a Part C, has scheme-supported narration. How can Part C in the Tamil Nadu GBS be more when compared to the other two parts?"...

Women's group activists also pointed out that pre-budget consultation, sectoral reviews, gender performance audit or analysis of previous GBS to assess adequacy of estimation. "There needs to be a way for the civil society organisations to be part of the discussion so that beneficial schemes can be formulated. Further there is also a need for a decentralised gender budget which can address issues regarding women from all classes," added Ms. Kamatchi.

Citing the example of the Punjab government where the Finance Department and Social Security, Women and Child Development Department prepare the GBS, she further added the departments could work together where the Social Welfare department could implement the scheme.
