ORDER:

The Government of India has adopted Gender Budgeting as a tool to ensure gender mainstreaming at all levels of governance. To appraise the actual progress on Gender Budgeting made by the State, Institutional and capacity building mechanisms initiated at the State level and how this is reflected in the improved allocation for women / gender equality, Government of India has requested to designate a nodal department and to constitute a Gender Budgeting Cell and convene regular quarterly meetings to discuss issues related to gender that requires attention.

2) The Government after careful examination, direct that Gender Budgeting Cell be created in Finance department. The Government sanction the creation of the following temporary posts to deal with the matter relating to Gender Budgeting in addition to the existing one post of Section Officer, one post of Assistant Section Officer and one post of Typist, in the Finance (Budget General Miscellaneous) section with effect from the date of issue of order for a period of one year or till necessity ceases, whichever is earlier:-

³⁾ The Government also direct that the name of the Finance (Budget General Miscellaneous) section be renamed as Finance (Gender Budgeting Cell and Budget General Miscellaneous) section.

- 4) The incumbent of the posts sanctioned in para 2 above are eligible to draw Pay, Grade Pay, Dearness Allowance, House Rent Allowance, City Compensatory Allowance and other allowances etc. as per orders in force.
- 5) The pay of the incumbents sanctioned in the para 2 above shall be debited to "2052.00. Secretariat, General Services - 090. Secretariat - State's Expenditure -AD. Finance Department - 01 Salaries (DPC 2052-00-090-AD- 0107)
- 6) Necessary funds will be provided in R.E./F.M.A. 2017-2018. Pending provision of such funds, the Section Officer (Bills), Finance Department is authorised to incur the expenditure. The Under Secretary to Government (Per.), Finance Department is requested to send necessary proposals to include the expenditure in R.E./F.M.A. 2017-2018 proposals and send the same to Finance (Public) Department without fail.
- 7) This orders issues with concurrence of U.O.No.12641A, Finance (Public) Department, Dated 31.07.2017, Finance (CMPC) Department No.37687 and A.S.L.No.1117 (One Thousand One Hundred and Seventeen).
